TUITION AND BOARDING FEES

Tuition and Boarding Fees are charged in advance in three equal instalments, at the beginning of Terms 1, 2 and 3. Two further fee statements are sent at the beginning and end of Term 4 for incidental expenses incurred during Terms 3 and 4.

International students pay a higher Tuition Fee as the School does not receive Government per capita grants for international students.

All Fees are shown and billed only in Australian Dollars.

OTHER FEES

Application Fee

A non-refundable Application Fee of \$440 (including GST) is payable when a student is registered for possible future enrolment for Kindergarten to Year 12.

Enrolment Fee

A non-refundable Enrolment Fee of \$7,500 is payable when a place at Cranbrook School (K-12) is formally offered and accepted.

Additional Charges

Additional charges are payable for optional subject tuition such as instrument lessons, excursions and for other activities outside the normal school program. Where GST exemptions do not apply on goods and services provided, the School reserves the right to charge GST on these additional charges.

Building Fund Donation per instalment (Tax Deductible)

A tax-deductible donation to the Cranbrook Building Fund of \$200 is included in the fee statements and goes towards the cost of acquisition, construction and refurbishment of buildings. Payment of this donation is voluntary.

Payment Options

Fees are payable by BPAY or online by credit card. Credit card surcharges apply for fees paid by credit card.

Fees are due and payable within 30 days from the date of issue of the fee statement.

Fees not paid by the due date, where no other agreement has been documented with the School, will incur an administrative charge of \$250 per account. In accordance with the School's Terms and Conditions of Enrolment, a failure to pay fees by the due date may also result in exclusion of a student from classes and/or extra activities or termination of enrolment.

ST MARK' S AND ST MICHAEL' S PRE-SCHOOL 2025 FEE SCHEDULE

2025 Start Strong Fee Relief from the NSW Government

The NSW Government in 2023 introduced a new preschool fee relief program through the Start Strong Affordable Preschool initiative.

If a child is enrolled in more than one service (e.g. at another preschool or long day care service), they can only access the Fee Relief Payment from one service at a time. Families must complete a declaration form to nominate which service they will access the fee relief from. The NSW Government provides the fee relief to St Mark's Pre-School and St Michael's Pre-School directly and we pass this fee relief to families as a reduction in each fee instalment.

If you elect to receive your fee relief from St Mark's Pre-School or St Michael's Pre-School, then fees outlined below in Fee Schedule A apply.

OTHER FEES

Application Fee

A non-refundable Application Fee of \$440 (including GST) is payable when a student is registered for possible future enrolment at the Pre-Schools.

Pre-School Deposit

A Deposit of \$3,000 is payable when a place at St Michael's or St Mark's Pre-School is formally offered and accepted. The Deposit is refundable after the child leaves the Pre-School if required notice is given and all accounts are paid.

Payment Options

Fees are payable by BPAY or online by credit card. Credit card surcharges apply for fees paid by credit card.

Fees are due and payable within 30 days from the date of issue of the fee statement.

Fees not paid by the due date, where no other agreement has been documented with the Pre-school, will incur an administrative charge of \$250 per account. In accordance with the School's Terms and Conditions of Enrolment, a failure to pay fees by the due date may also result in exclusion of a student from classes and/or extra activities or termination of enrolment.
