The Duty Supervisor – Aquatic & Fitness Centre (AFC) will contribute to the effective operation of the AFC by facilitating lifeguard supervision and providing general pool operations assistance.

Reporting to the AFC Manager, the role will support the safe day-to-day operations of the AFC by supervising a team of lifeguards and performing lifeguard duties, conducting safety and equipment inspections and pool testing and coordinating set up/pack down each day. The Duty Supervisor works closely with all other members of the AFC team to insure a safe aquatic environment.

- A demonstrated understanding of child safety and appropriate behaviours when engaging with children.
